2. Minutes of last meeting

2.1 The minutes of the last meeting held on 13 June 2007 were accepted as a true record, subject to replacement of "Ann George" in list of apologies received with "Anne George".

3. Matters arising from minutes

- 7.1 Kevin Mulley (KM) reported that the working assumptions group had not yet been convened by The National Archives (TNA). Colin Gale reminded the meeting that HARG's representatives on this group would be Vicky Rea (VR) and Samantha Farhall (SF)
- 8.1 KM reported that a redraft of the Code of Practice on Records Management, issued under Section 46 of the Freedom of Information Act, was now available on TNA's website for

consultation. Catherine Redfern (CR) summarised changes made, as outlined in a presentation made by TNA's Susan Healy, as follows:

- The revised guidance aims to focus on records management (RM) outcomes rather than define RM processes
- It can be used to assess existing organisational RM policies
- Electronic records are now treated throughout the code, rather than as a separate class
- It contains better cross-referencing to other legislation, such as the Data Protection Act, and more guidance on destruction processes.

It was hoped that the revised Code would be formally issued by the Lord Chancellor at the close of the consultation period next year. It was noted that Department of Health input on the changes was being led by Paul Eveson.

4. E-Learning project to support citizenship education

4.1 Caroline Smith, Bethlem Royal Hospital Archives and Museum's Education and Outreach Officer, gave a presentation on this topic, and subsequently answered questions.

5. Update on matters discussed at HARG committee meeting

- 5.1 CG gave an update on matters discussed at the HARG meeting as follows:

6. Research sub-group

- 6.1 Jenny Haynes (JH) gave an update on the work of the research value sub-group, which met on 18 September 2007 to discuss the production of guidance on appraisal of health records which would
 - Fulfil the promise made in Part 2, Annex D of the *NHS Code of Practice on Records Management* (2005), viz. that "The Health Archives Group will advise on the current and potential research uses of NHS archives, including patient records";
 - give an overview of the importance of health archives for research;
 - include generic advice on appraisal;
 - include examples of various types of research use made of health archives.

7. Records Management sub-group

- 7.1 Michael Goodson (MG), who with CR is HARG's representative on Connecting for Health's Records Advisory Group, advised that the last meeting of this group had taken place in March 2007. He referred the meeting to the minutes of that meeting, available online at http://www.connectingforhealth.nhs.uk/systemsandservices/infogov/policy/advisory/meetings, and to the summary available in the 'News and events' section of the HARG website.
- 7.2 CR reported that the NHS Code of Practice on Records Management was due for revision following the completion of the Information Governance Toolkit. News of revision start date is awaited.

7.3 CR reported that version 1 of a Business Classification Scheme (BCS) for NHS corporate (non-clinical) records, currently under development as a joint initiative of the Health Archives & Records Group and the Records Management Society, was due for completion by the end of December 2007. Ten top-level functions have been identified for inclusion in the scheme, and work on the identification of second-level functions is proceeding. A press release had been issued, and would be mounted on HARG's website in due course. When completed, the BCS itself would be published on the Department of Health's website.

7.4 CR alerted the meeting to a draft BSI standard on security requirements for electronic health records, which she had seen and on which she had made comments.

9.1 CR advised that current NHS publication scheme agreements expire in May 2008, and that new model schemes must be adopted by December 2008. A working group representing NHS bodies, led by Peter Wilson of Sheffield Teaching Hospitals NHS Trust and Sue Markey from the Office of the Information Commissioner, will be revising the NHS model scheme - for details see http://www.ico.gov.uk/about_us/news_and_views/current_topics/FOI_publication_scheme_initiative.aspx. CG underlined the importance of ensuring that an optional archives class was retained in the scheme, so that places of deposit maintained by NHS organisations could continue to claim exemption under Section 21, when appropriate, in response to requests made under the Freedom of Information Act for archival material.
